About the Fund

The **Acruence Active Hedge U.S. Equity ETF (XVOL)** The Acruence Active Hedge U.S. Equity ETF (XVOL) is an actively-managed exchange-traded fund (ETF) that seeks capital appreciation with less volatility than the S&P 500 Index.

Acruence seeks to achieve its objective by investing nearly all of the ETF's assets in a broad-based U.S. large-cap equity portfolio, composed of approximately 50% momentum and growth stocks and 50% dividend yield stocks. The fund seeks to enhance income by call and put writing, selectively, while seeking to reduce volatility by purchasing options contracts on the VIX (i.e., the Cboe Volatility Index).

Acruence uses proprietary, volatility-based algorithms to determine the number of options contracts to purchase, as well as the strike price(s) and expiration date(s) of the options.

The Fund may actively and frequently trade all or a significant portion of the securities in its portfolio which may increase the Fund's expenses and also cause adverse tax consequences.

The Fund is actively-managed and may not meet its investment objective based on the Sub-Adviser's success or failure to implement investment strategies for the Fund.

The fund is classified as non-diversified. Because it is non-diversified, it may hold large positions in a small number of securities. To the extent it maintains such positions; a price change in any one of those securities may have a greater impact on the fund's share price than if it were diversified.

The Fund is a recently organized management investment company with no operating history.
